

Foreign High School Credential Submission - Salon Schools Group

If you completed your high school or secondary school education overseas, please note the following:

Because the programs of study at Salon Schools Group requires proof of high school graduation, you will be required to use a credential evaluation company to obtain an official evaluation report showing that your foreign credentials are equivalent to a U.S. High School Diploma.

Please note that a professional evaluation is the only way that credentials from outside the USA can be submitted to the Salon Schools Group.

A professional evaluation must be obtained from agencies holding current memberships with NACES (National Association of Credential Evaluation Services). For more information concerning which documents you need to submit in order to obtain an appropriate evaluation please contact the NACES member evaluation agency of your choice.

- * Many companies will not require that your documents be translated for evaluation. Please consult with the specific company of your choice regarding the need for translations.
